for a just energy transformation of Eastern Wielkopolska

Concluded on **3 April 2019** in Konin between the participants:

Preamble

Participants of this Agreement, being aware of the legitimacy of implementing measures for a just energy transformation of the Eastern Wielkopolska Region ("Region"), taking into account sustainable development and respect for the social side, declare the will to cooperate resulting in new initiatives and investments in the Region.

§ 1.

Participants accordingly appoint the Coordinator of the Agreement - Regional Development Agency S.A. in Konin, to coordinate activities related to accession and withdrawal from this Agreement.

§ 2.

Participants express the will to cooperate in the following area:

- 1. Participation in the preparation of initiatives addressed to the Region related to the process of energy transformation.
- 2. Mutual support in the process of just transformation, respecting the interests of each party.
- 3. Mutual cooperation in the area of Region's participation as part of the Coal Regions in Transition Platform ("Coal Platform").

- 4. Mutual support in the process of raising funds for the implementation of projects addressed to the Region.
- 5. Supporting initiatives and investments in the Region aimed at creating new jobs in the energy sector and outside the sector.

§ 3.

- 1. This Agreement is an expression of the will of the participants to cooperate.
- 2. The agreement is open to all entities from the Eastern Wielkopolska Region approving the content of the preamble and the provisions of this Agreement.
- 3. Representatives of entities from the Eastern Wielkopolska Region may express their will to join the Agreement by submitting an appropriate statement in writing to the Coordinator of the Agreement, in accordance with the model constituting Annex No. 1 to the Agreement.
- 4. This Agreement does not involve any financial obligations for participants.
- 5. Each participant may withdraw from the Agreement by a declaration of intent made in writing to the Coordinator of the Agreement. The template of the statement on withdrawal from the Agreement is attached as Annex 2 to the Agreement.

§ 4.

The agreement was concluded for an indefinite period.
